The Mount Prospect Park District Central Community Center Fitness Center (1000 W. Central Road, Mt. Prospect, IL 60056) is a Recreation Center – Central to the Park District. The Park District intends to replace and upgrade the flooring and the counter in the Fitness Center. We recommend the following funds be reimbursed to the Mt. Prospect Park District for Accessibility improvements. The funds will be used in two ways 1) to a contractor for supply and installation through the Park District and 2) by the Park District for A/E Fees.

The first item is the flooring. The Park District is proposing to install the Floorfolio Industries Luxury Vinyl Tile Sands of Time Series 3mm thick and 22 mil wear course. The Vinyl Tile meets ADA code for slip resistance complying with ASTM D2047 and is firm and stable flooring.

The total floor area for replacement is 3,530 sf.

- Request reimbursement for 5' width for main pathway through the fitness center. This main Pathway measures 54 lineal feet or 270 sf. The pathway shall meet the current ADA Standards (2010) and Accessibility as determined in Chapter 4 Accessible Routes 402 accessible Routes 403 Walking Surfaces including 403.5.3 Passing Space.
- 2) Request reimbursement for 30" wide pathways to and from equipment this area also includes the use zone of 30" x 40" for individual pieces of equipment or 234 lineal feet and 585 s.f.
