NWSRA General Therapeutic Recreation Programs & Services

Registration for General Therapeutic Recreation fall programs began on August 10. NWSRA is still offering both in person and virtual programs. As of October 20, over 720 registrations have been received. Music lessons are a successful and popular program this season. Full registrations were received for piano and voice lessons for all three months. Young adults were back rocking in the suburbs by having a bonfire, Wii game night, ice cream in downtown Arlington and much more. The virtual program Monday Night Fun, consistently has 5-10 participants each week. Participants play games such as Scene It, Disney Trivia, Deal or No Deal, and Emoji Bingo all while enjoying a snack and sharing some laughs. A 1:1 Art Sampler with a Certified Therapeutic Recreation Specialist, held throughout the fall, provided a long-time participant the opportunity to continue working on their social skills. Katherine, a resident of Inverness, increased her self-expression by creating art projects tailored to her interests of classic Disney movies and birds.

PURSUIT Community Adult Day Program

Throughout the month of September, all five PURSUIT locations visited Goat Yoga Chicago to practice yoga in the company of goats! Each group was guided through basic yoga poses while being able to interact with the animals. The staff at Goat Yoga Chicago adapted each yoga pose and being so accommodating of our groups. We are looking forward to returning next year.

A special thank you to Chicago Ride for Autism Speaks for their donation to the PURSUIT Adult Day Program. This great yearly collaboration helps support exceptional programming at PURSUIT for adults with disabilities 22 and older.

NWSRA Social Clubs

TGIF Social Club visited City Works in Schaumburg for dinner while the Friday Night Social Club had a Fun and Fondue Party in Palatine at Plum Grove Park. The night was filled with great food & laughs. The final outing for October will be a joint club with Magician providing entertainment for the evening.

Inclusion Services

The inclusion team continues to support NWSRA Member Park Districts in a multitude of ways during the staffing crisis, including providing training for park district staff running the before and after care programs. Staff have seen great success in providing these trainings as well as a desire to work as a team and understand their role in inclusion, behavior management, and empathy. Schaumburg Park District received two separate nights of trainings, 40 attendees at each, as well as Elk Grove and Rolling Meadows Park District among the other Member Park Districts that opted in for additional training for their staff. RE: SLSF Update for the November NWSRA Board Meeting

Sponsorships: Sponsorship dollars are part of the SLSF event budgets. The FY 2021 budgeted amount is \$61,200. To date, \$87,351 has been received, which is 143% of its goal. SLSF secured 8 new sponsors for the Buffalo Grove Golf Classic, 10 new sponsors for the Moretti's/NWSRA Golf Classic, 9 new sponsors for the Women's Golf Outing, 14 new sponsors for the Arlington Golf Classic, 6 new sponsors for the Celebrate Ability Gala, and so far has 4 new sponsors for the upcoming Gold Medal Fashion Show.

Grants: The FY 2021 Grant budgeted amount is \$83,000. To date, SLSF has applied for \$189,013 in grants with \$157,724 approved; some grants are still pending. SLSF will be submitting additional grants throughout the year in order to meet the needs of NWSRA programs and the renovation construction of the 6th programming space.

Events: The FY 2021 Events budgeted amount is \$208,585. The budgeted amount is lower than previous years due to the uncertainty of state and federal guidelines due to the COVID-19 pandemic, but higher than the actual funds raised through events in 2020. The total amount received in event dollars as of November 10th is \$242,008 which is 116% of the budgeted amount. A portion of those dollars represent event sponsorships as shown in the sponsorship portion of this report.

The 28th Buffalo Grove Golf Classic was held on Wednesday, August 11, 2021 and netted \$32,269.92, which is over \$12,000 higher than the 2020 net. Over 100 golfers were in attendance including Senator Adriane Johnson.

The 34th Moretti's/NWSRA Golf Classic was held on Wednesday, August 18, 2021 and netted \$18,457. In 2020 this event was not held due to COVID – 19 and this year 69 golfers came out to show their support of this annual event.

The 29th Women's Golf Outing was held on Wednesday, September 1, 2021 and netted \$22,244.78, which is \$7,400 over the budgeted amount. This year brought in 90 golfers and 16 caddies raising \$10,211.33 in the Caddy Auction.

The 29th Arlington Classic Golf Outing was held on Thursday, September 9, 2021 and netted \$21,723.98, which is almost \$5,500 over budget! The outing brought 72 golfers and a wide variety of new sponsorships!


The Celebrate, Ability Gala was held on November 5th as an in-person/virtual hybrid event with 182 attendees and netted \$58,708 which is 157.8% of budgeted goal.

Grants to NWSRA: The Board approved a grant to NWSRA in the amount of \$260,000 for FY 2021. SLSF has granted NWSRA \$51,124 in the May Ask.

Outreach:

- During May to October, SLSF presented at 9 civic organizations about the work of NWSRA and SLSF.
- 23 NWSRA Board/SLSF Board, NWSRA/SLSF Staff and families members volunteered at the Ride for Autism Speaks and in return the organization donated \$2,000 to SLSF.
- Staff are currently talking with two local nonprofits about collaborative fundraisers.
- Staff are attended 12 networking events to increase the public profile of SLSF and NWSRA.

- SLSF is currently running a fundraiser with Kilwins in downtown Arlington Heights and will be hosting a collaborative event with the Metropolis Performing Arts Centre in April.
- In September and October SLSF staff attended 15 networking and outreach events to increase the public profile of SLSF and NWSRA.

AN ORDINANCE AUTHORIZING AND PROVIDING FOR THE CONVEYANCE OR SALE OF SURPLUS PERSONAL PROPERTY OF THE NORTHWEST SPECIAL RECREATION ASSOCIATION COOK COUNTY, ILLINOIS

WHEREAS, the Northwest Special Recreation Association, Cook County, Illinois ("Park District") owns personal property as described in Addendum A. hereinafter known as the "Property," and

WHEREAS, pursuant to Section 8-22 of the Park District Code (70 ILCS 1205/8-22)("Code"), the Park District is authorized to sell, convey or donate any personal property that in the opinion of three-fifths of the members of the Board of Park Commissioners then holding office is no longer necessary, useful to, or for the best interests of the Park District; and

WHEREAS, the Board of Park Commissioners ("Board") has reviewed a staff report finding that the Property is no longer useful to the Park District and recommending its sale, donation or disposal and the Board concurs with that recommendation.

NOW, THEREFORE, BE IT ORDAINED by the Board of Park Commissioners of the Northwest Special Recreation Association, Cook County, Illinois, as follows:

Section 1. The Board finds that all of the recitals contained in the preamble to this Ordinance are true and correct and does hereby incorporate them into this Ordinance by this reference.

Section 2. The Board finds that the Property is no longer necessary and useful to the Park District and declares it to be for the best interests of the Park District and its residents to dispose of the Property in the following manner:

Sell the Property to the highest bidder.

or

Trade-In the Property

or

Donate the Property to such person or entity that will make use of the equipment.

0

Dispose of the Property if the District is unable to sell or donate identified equipment.

Section 3. The seller, Northwest Special Recreation Association, hereby expressly disclaims all warranties, either expressed or implied, including any implied warranty of merchantability or fitness for a particular purpose. The Northwest Special

Recreation Association neither assumes nor authorizes any other person to assume for it any liability in connection with the sale of said items.

The buyer agrees to purchase said items in an "as is" condition with all faults. The buyer understands that the seller does not expressly or implicitly warrant that the said items meet or comply with any applicable safety standards (examples: ASTM, OSHA, CPSC). The buyer is solely responsible for determining that the said items are appropriate for any and all particular uses.

The buyer further agrees to indemnify, hold harmless and defend the Northwest Special Recreation Association and its officers, agents and employees from any and all claims resulting from injuries, damages and losses arising out of, connected with, or in any other way associated with the use of said items.

Section 4. The Board authorizes and directs the Executive Director take such action necessary to sell, donate or dispose of the Property as herein authorized.

Section 5. This ordinance shall be in full force and effect from and after its adoption as provided by law.
