The Buffalo Grove Park District respectfully requests approval from the NWSRA Board of Directors that the following expenditures of \$403,685.25 be paid from the Park District's Special Recreation Levy. The improvements listed will provide direct benefits to the partnership that the Park District has with NWSRA and the participants that are served through our Joint Agreement. Details of all expenses follow these summaries.

ADA Surface Work: The Park District had renovation projects at three different parks that included ADA compliant surface work. They included bike path renovations at Willow Stream Park, Alcott, and Longfellow Park. The ADA specific work cost for each site is as follows. Willow Stream Park bike path renovation, 5' of an 8' path at \$2,554, bike path renovation Longfellow Park, 5' of 8' path at \$8,494.25, and sidewalk path renovation at Alcott 5' of 5' path at \$10,524. Additional material including a detail of costs is attached.

<u>Green Lake Park Fishing Deck Design</u>: The Park District has paid for the consulting costs of an upcoming project that includes an ADA accessible fishing pier. The Landscape Architect Upland Design, has indicated that 20% of the deck engineering fees is the typical costs they attribute to ADA.

<u>CAC Interior Renovation</u>: The Park District asked Legat Architects to detail out the ADA accessible compliant components for the Community Arts Center renovation project. The total renovation cost of the project is \$2,655,000. Based on the attached detailed list the ADA component costs and A/E fees total \$297,000.

<u>Playground Surface Replenishment</u>: We are requesting reimbursement for Engineered Fiber safety surface replenishment for following parks, Mill Creek, Old Farm, Parkchester, Prairie Grove, Veterans, Apple Hill, Mirielle, Rolling Hills, and Willow Stream. The total cost is \$19,929.00.



GEOMETRIC AND PAVING PLAN

- All pavement dimensions are to edge of pavement, unless otherwise noted. E=edge of pavement, B=back of curb, F=face of curb. Radii dimensions are to back of curb.
- Provide 1.90% cross slope and 4.5% maximum longitudinal slope on all sidewalks and pedestrian path ways unless otherwise indicated. Illinois accessibility code requires a maximum constructed cross slope of 2.00% and longitudinal slope of 5.00%.
- Install bituminous pavement as shown. Refer to detail sheet for specific pavement sections and general note sheet for construction, testing and compaction requirements. 3.
- Contractor shall install temporary erasion control seed and blanket as necessary to meet soil erasion and sediment control requirements. Refer to notes and details throughout the plan set for specific material requirements.
- For final restoration, the contractor shall be responsible for restoring all disturbed turf areas and proposed turf areas as follows:
 - a.

 - Prior to placement of topsoil restoration area subgrade material shall be rotatilled and re-compacted to a maximum of 80% standard proctor to a depth of 6°. Spread a minimum of 6° of existing site salvaged screened topsoil or new pulverized topsoil on all disturbed areas.

 Topsoil must be free of litter, brush, rocks and earth clods of greater than 1 inch in any dimension. Contain between 1%-10% organic matter, 12%-50% day, and less than 55% sound content. pH shall be between 6.0 and 8.0.



The Park District has requested a breakdown of the pricing related to the design and construction of ADA compliant components for the Community Arts Center renovation project. We spoke with the General Contractor and reviewed the Schedule of Values from Pay Application 3 to determine the following breakdown.

•	ADA compliant Sidewalk/Curb Modifications for new entrance.	\$36,400
•	ADA compliant Cabinets, Counters, and Benches	\$31,000
•	ADA compliant Door Hardware	\$72,800
•	ADA compliant recessed walkoff mat and floor transitions	\$15,000
•	ADA compliant wheelchair lift for the Control Booth	\$28,000
•	ADA compliant plumbing fixtures for the (2) toilet rooms	\$11,850
•	ADA compliant electrical power/data devices	\$21,450
•	A/E fees for Schematic Design which complies w/ ADA requirements	\$34,500
•	A/E fees for Design Development which complies w/ ADA requirements	\$46,000
