RE: NWSRA ADA Transition Plan Town Hall Meeting

On September 18, 2023, NWSRA hosted, along with guest speaker John McGovern from WT Engineering, a town hall meeting with participants, stakeholders, and community members to discuss and update them on the status of our ADA Transition plan. Attached for your review, is the NWSRA Programming Space & Office Space Facility Survey results for 2023. NWSRA finds the survey process regarding facilities an integral part of ensuring we are meeting the mission, providing outstanding opportunities for individuals with disabilities.

NWSRA had 24 registrations for the meeting, and 7 attendees. John McGovern from WT Engineering presented the ADA inspection report that was conducted for NWSRA in 2018. Attendees learned the status of the NWSRA transition plan and what tasks/upgrades, identified by WT, have been completed as well as the status of the items not completed. 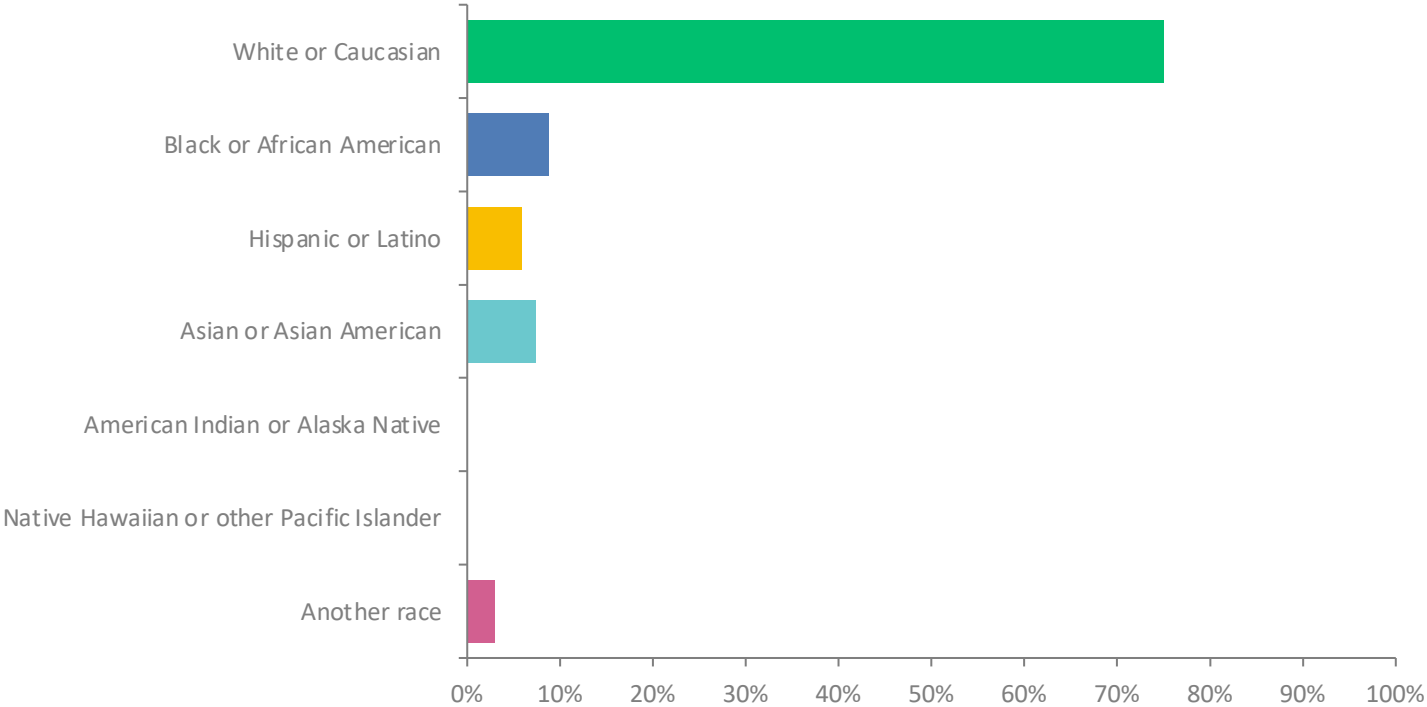

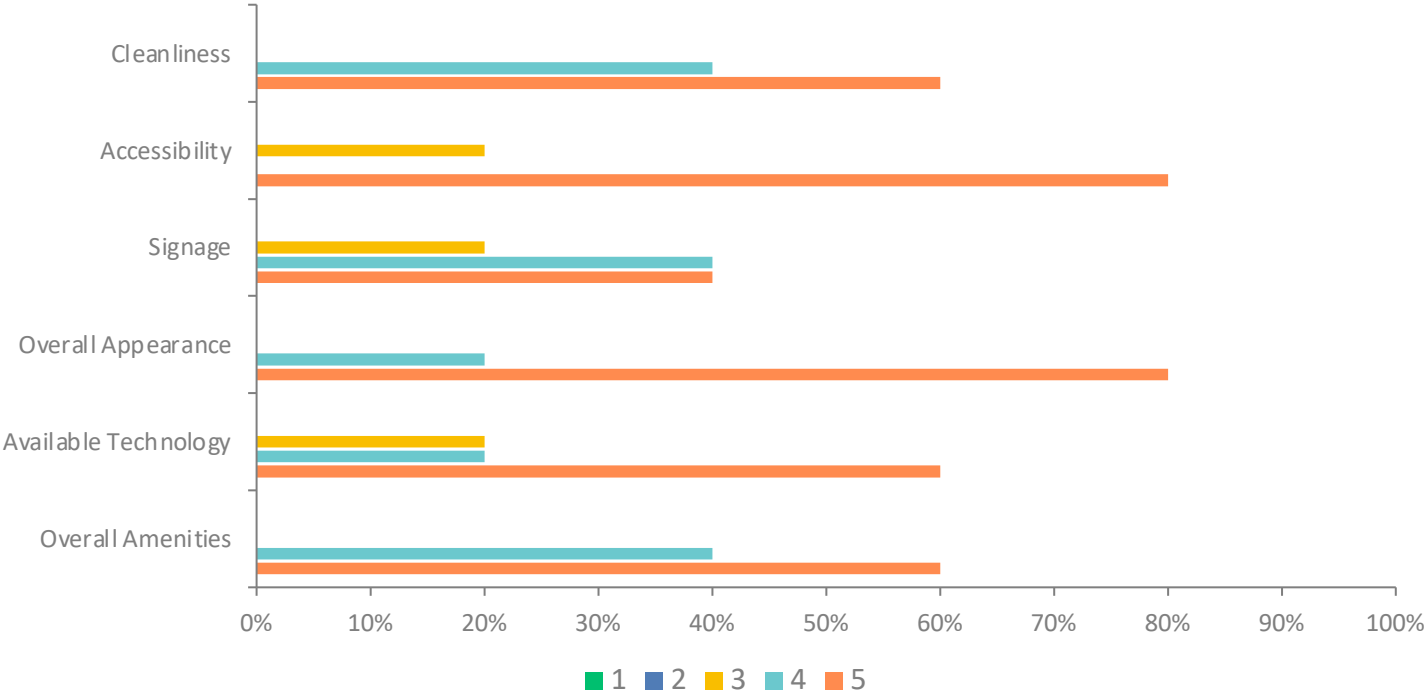


Buffalo Grove

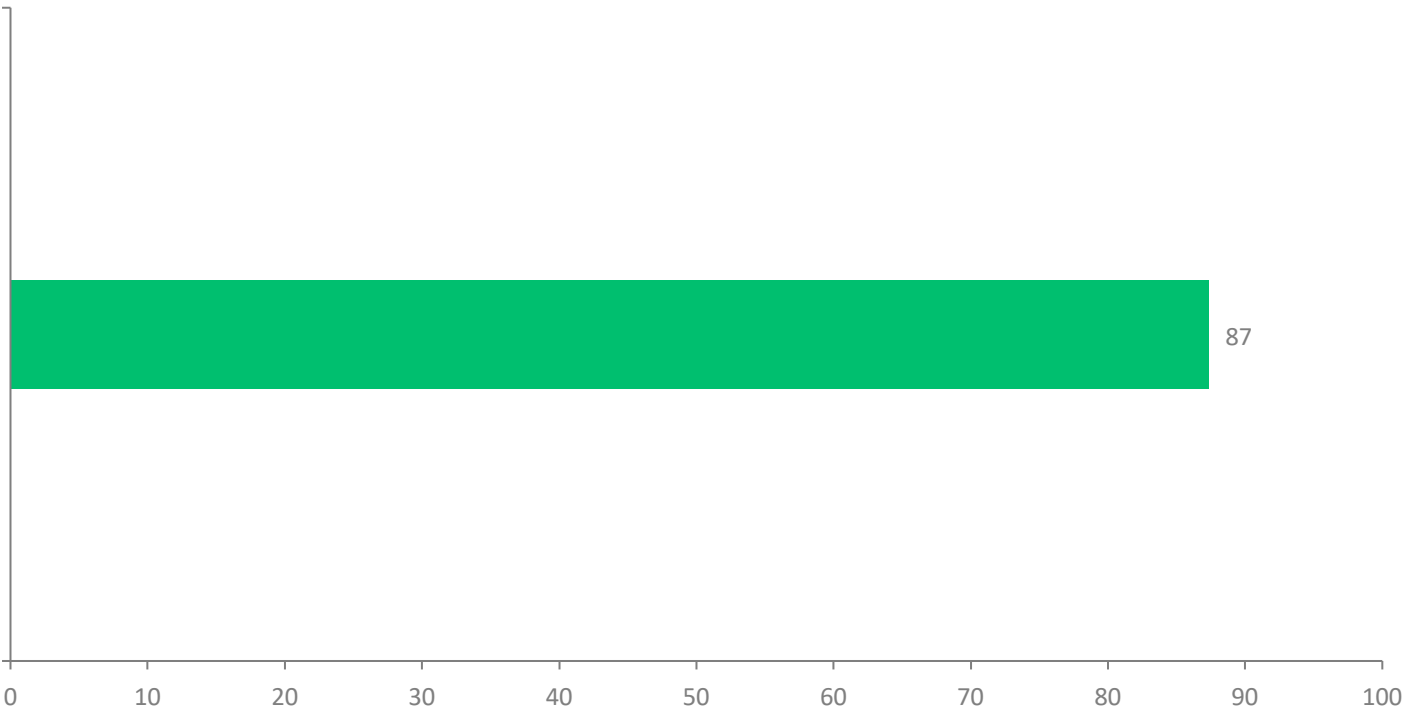


On a scale of 1-5 (1 being very unsatisfied, 5 being very satisfied), please rate your satisfaction with the following features of the facility:

On a scale of 1-5 (1 being very unwelcomed, 5 being very welcomed), how welcomed do you feel at the NWSRA programming space within the Park District facility?

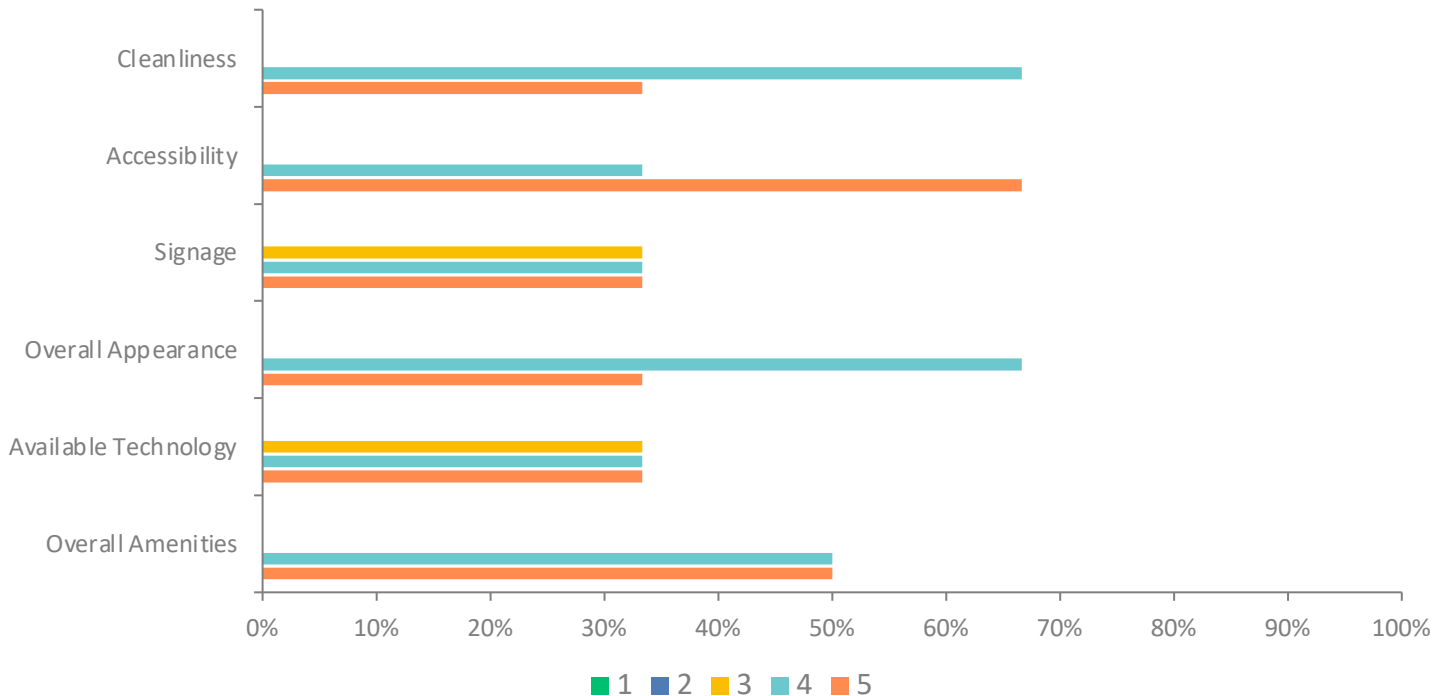


Hanover Park

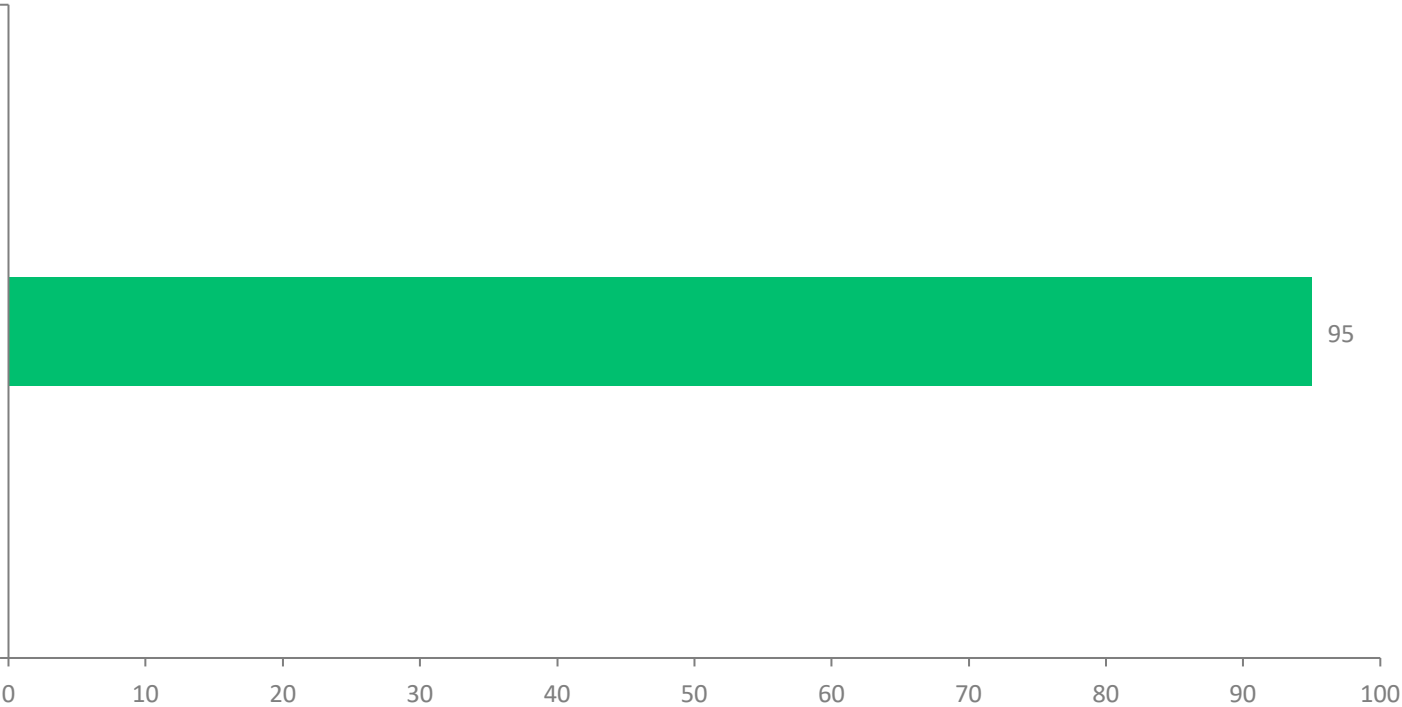

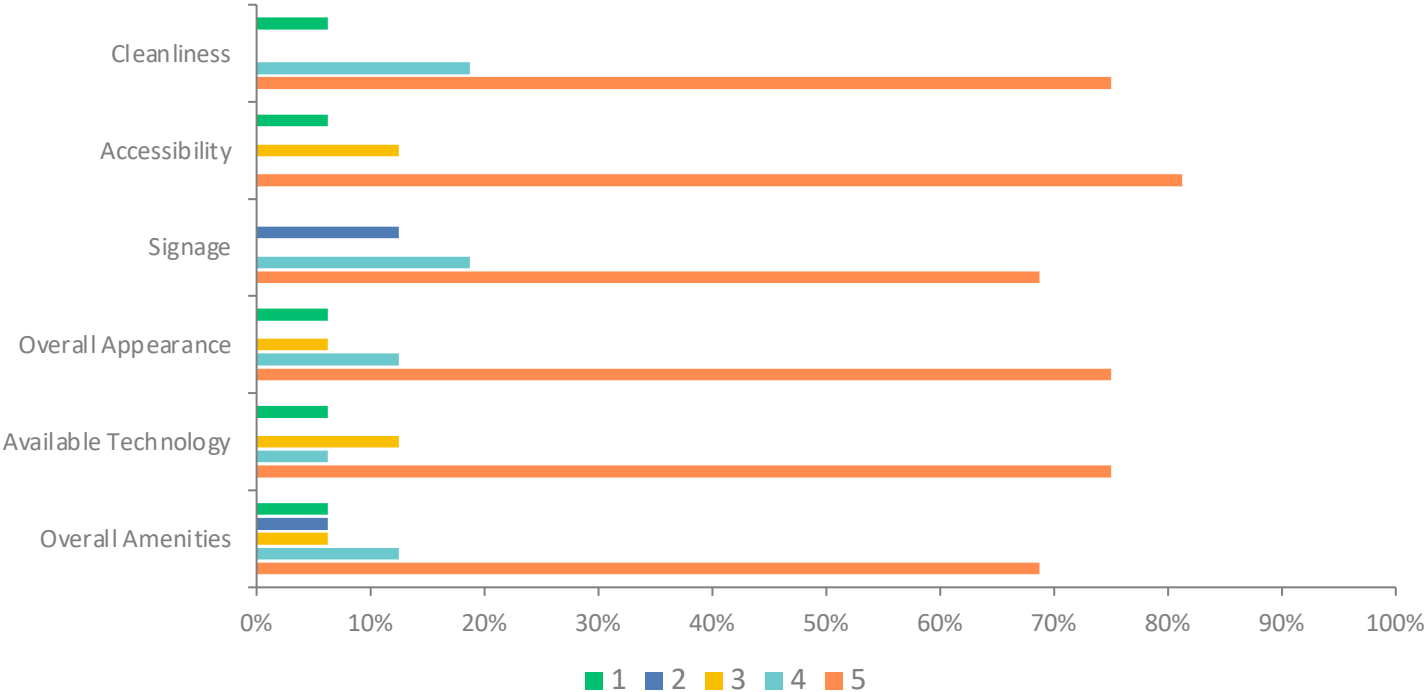


Mt. Prospect

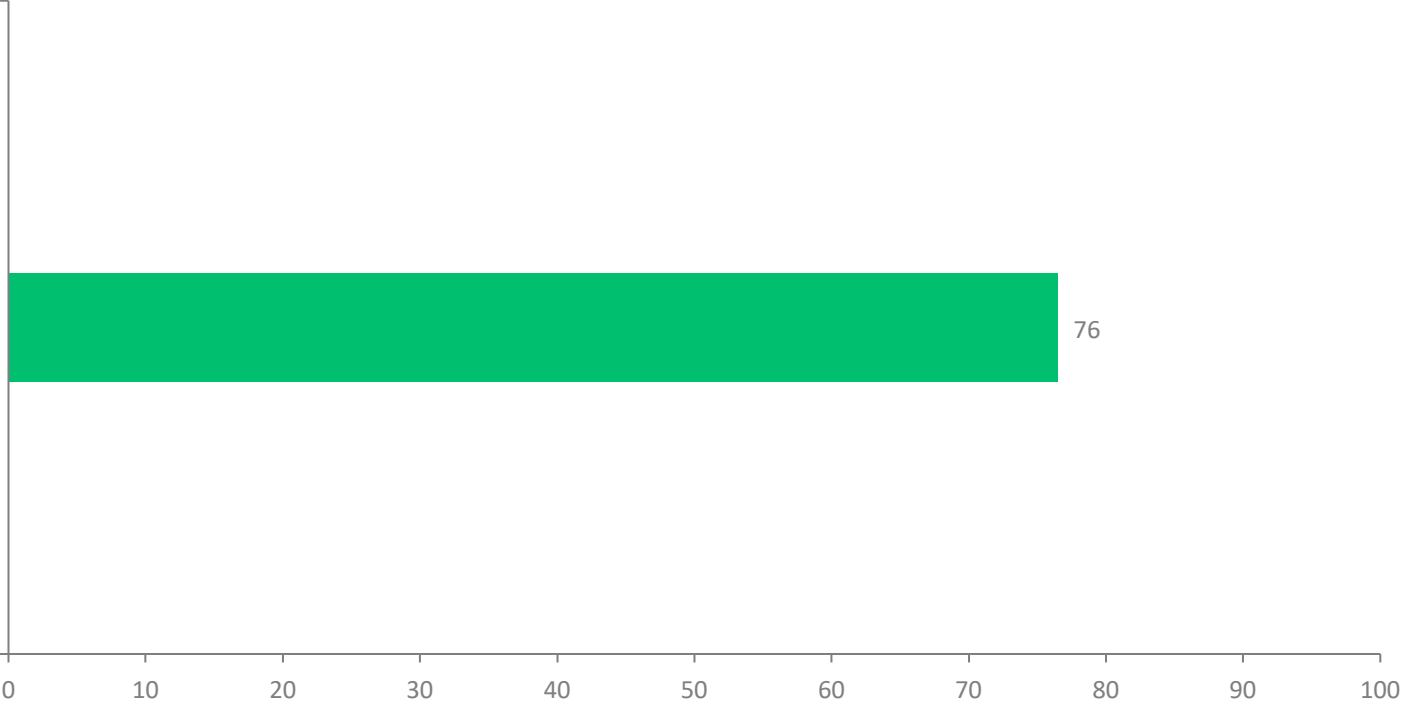

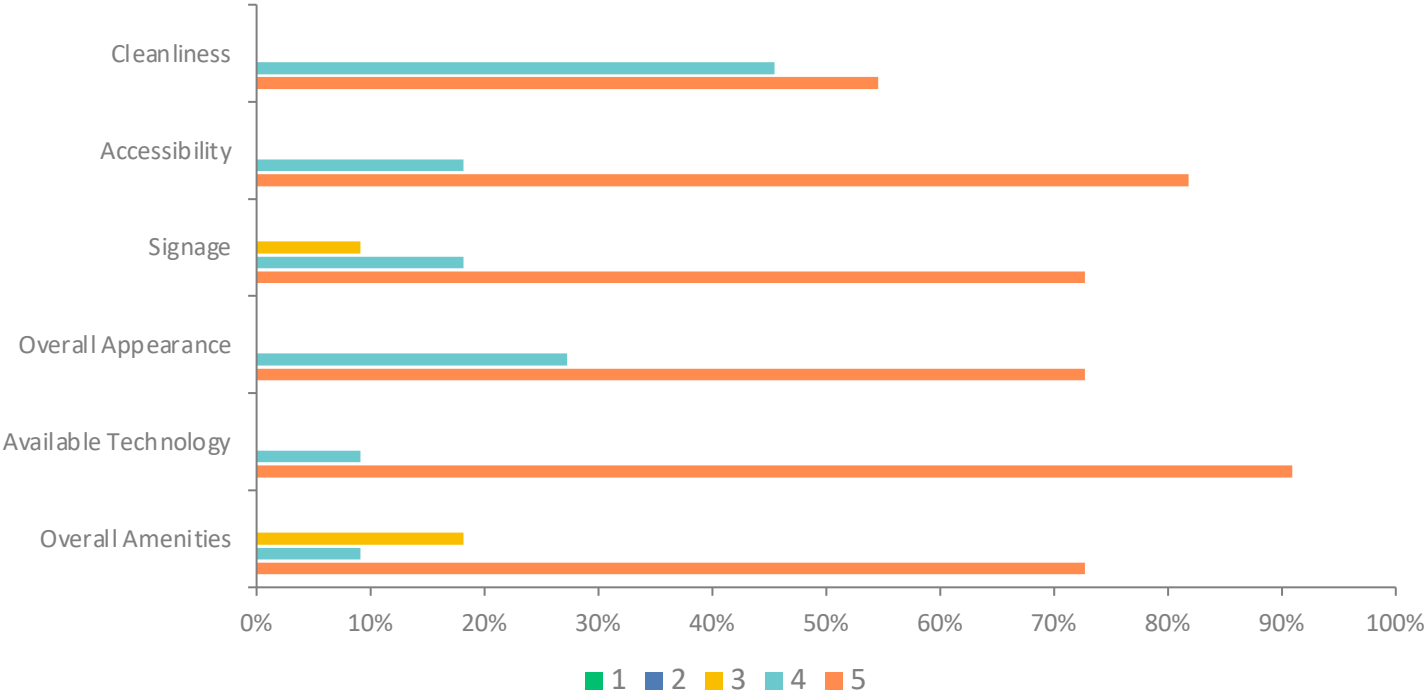


Rolling Meadows

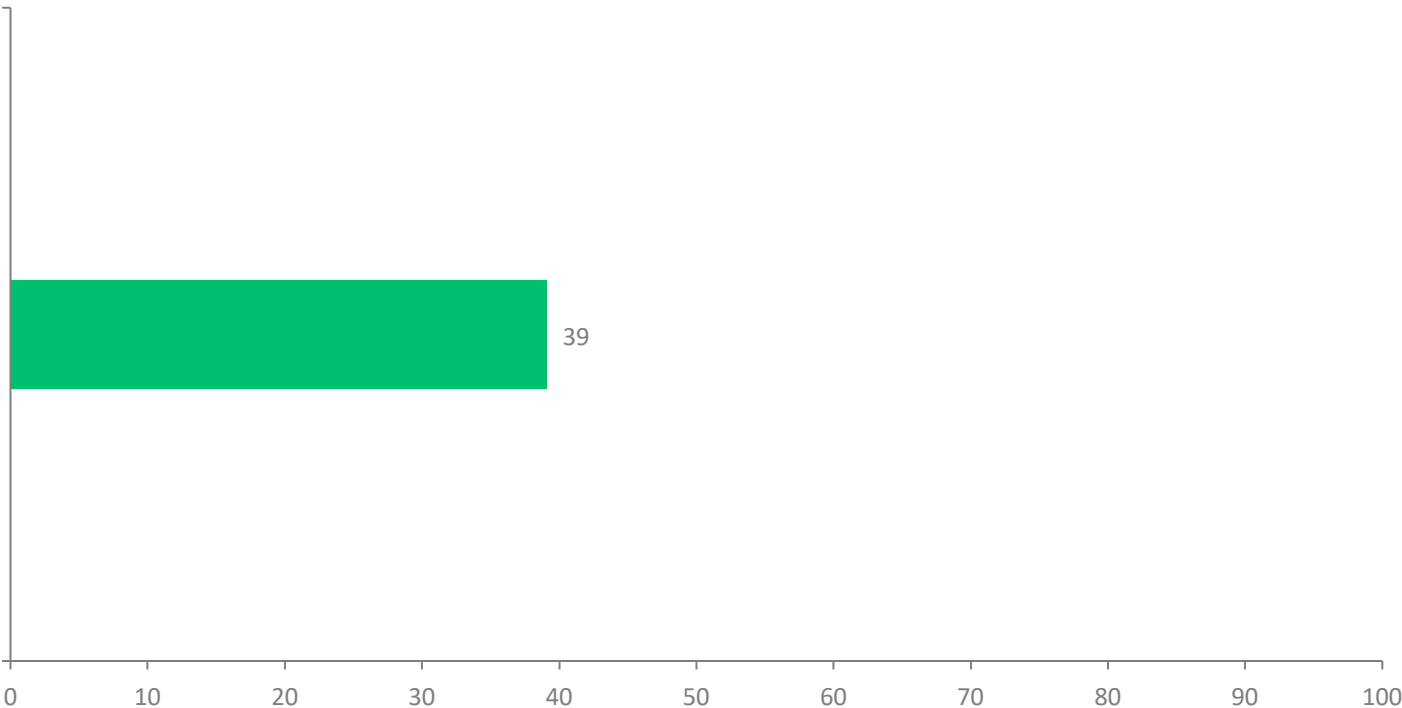

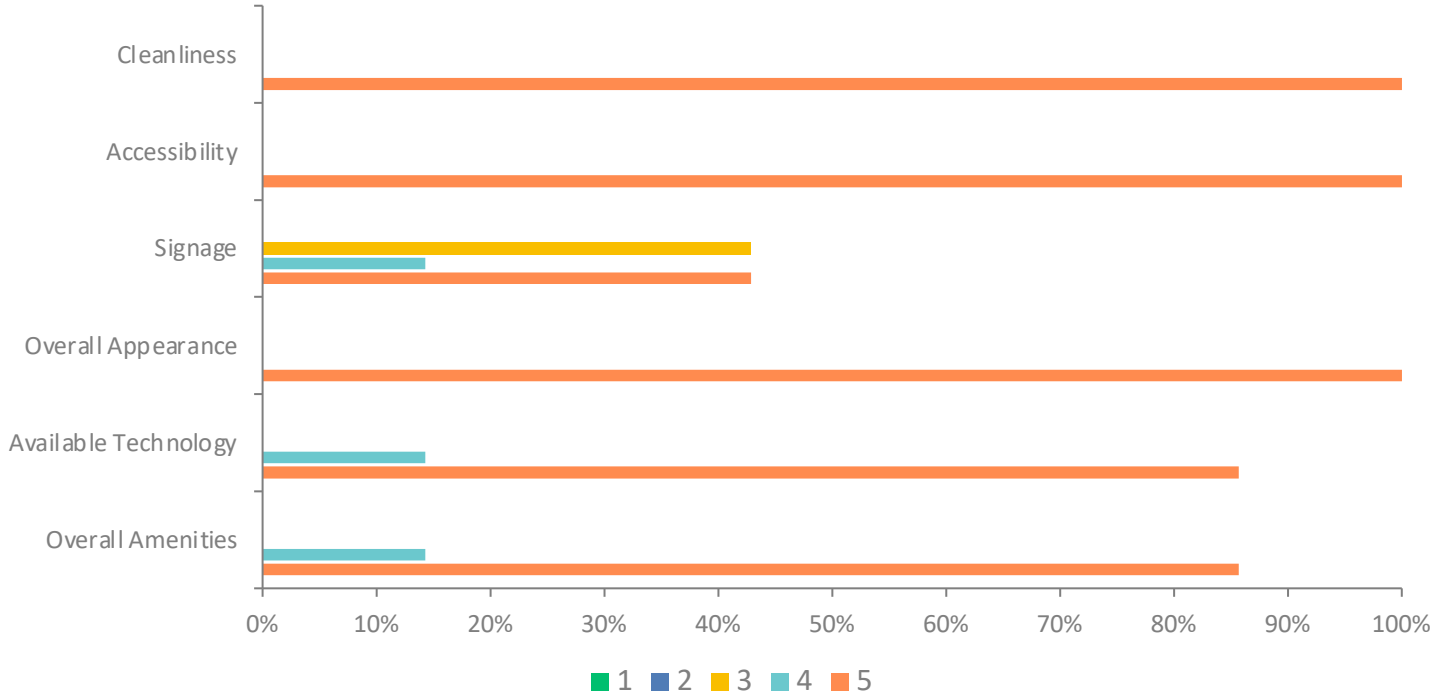

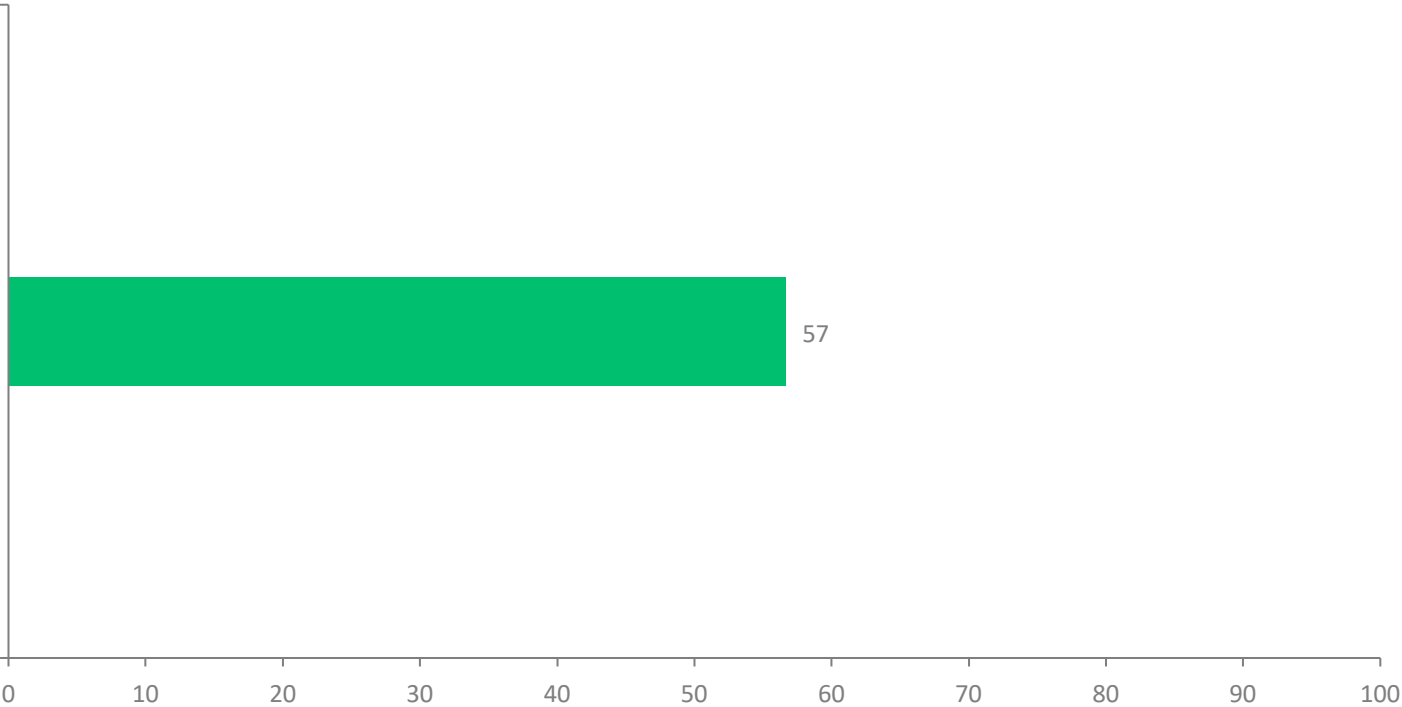

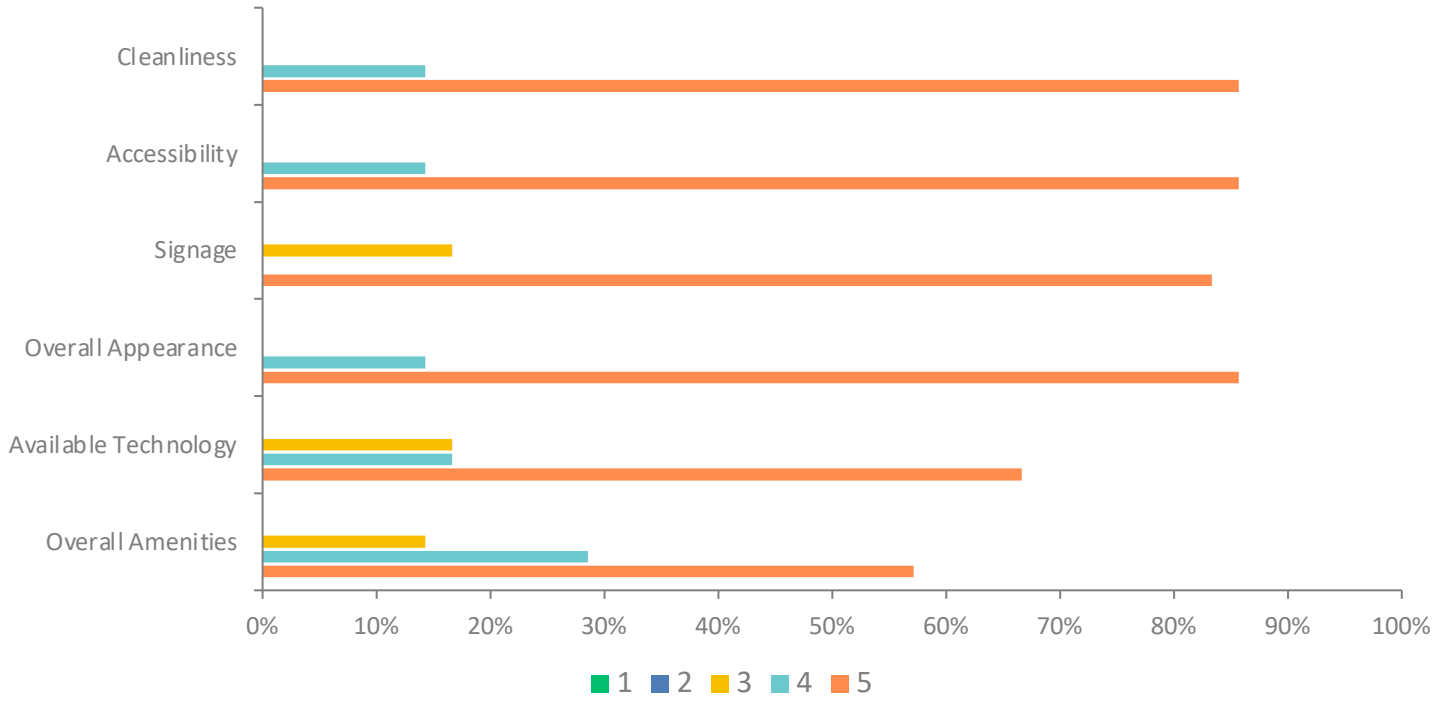


Hoffman Estates

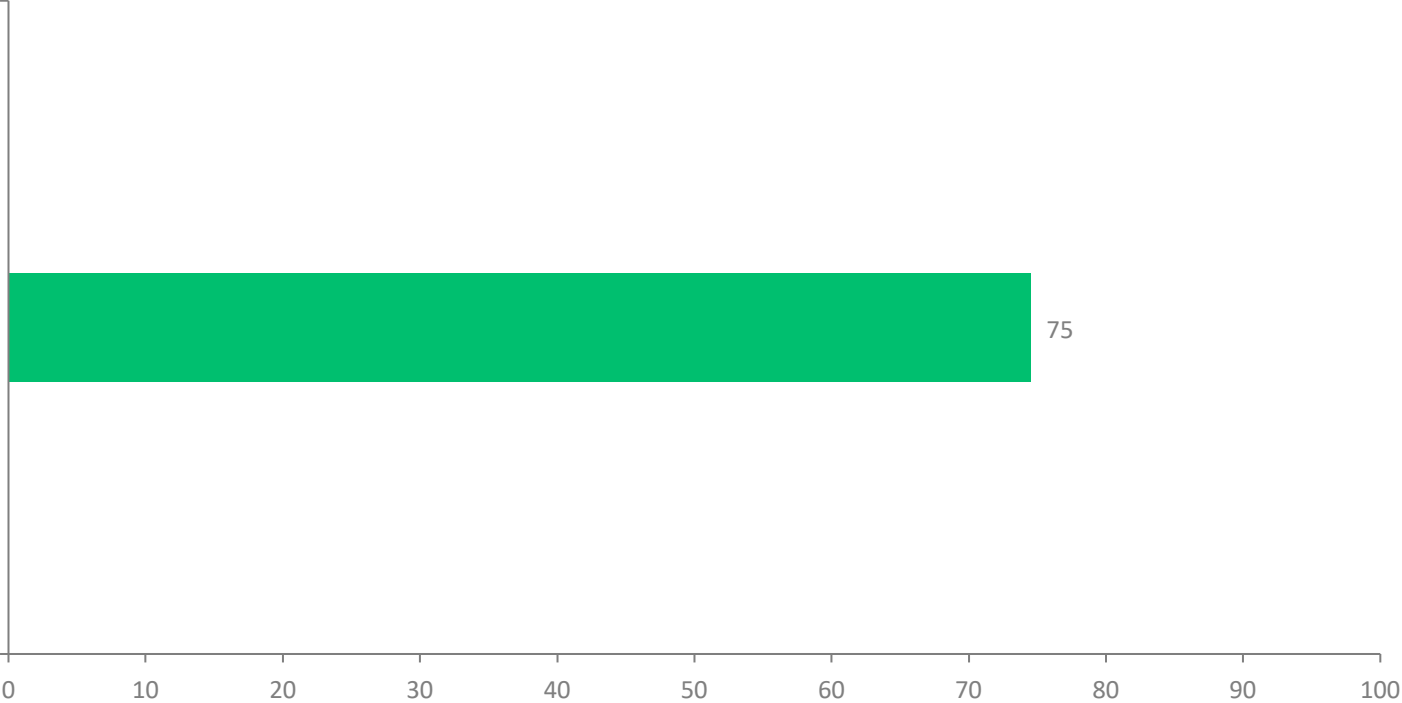

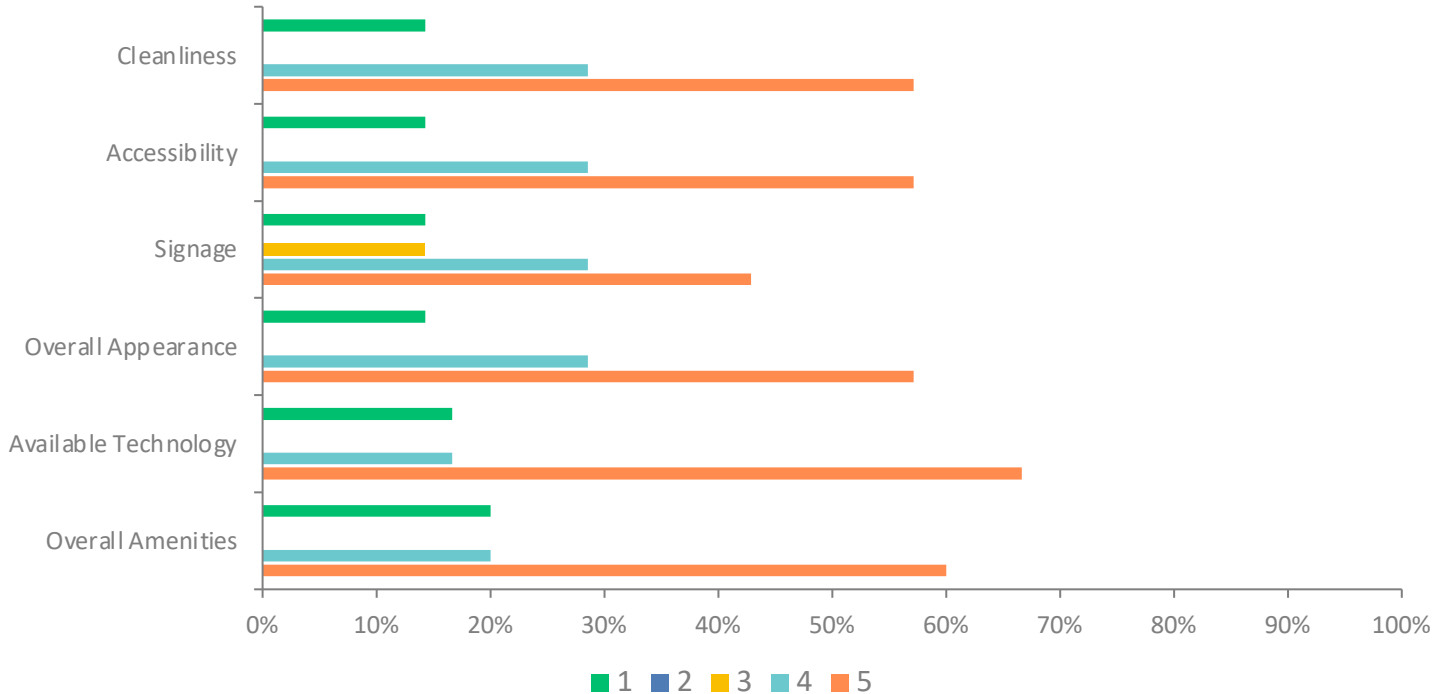

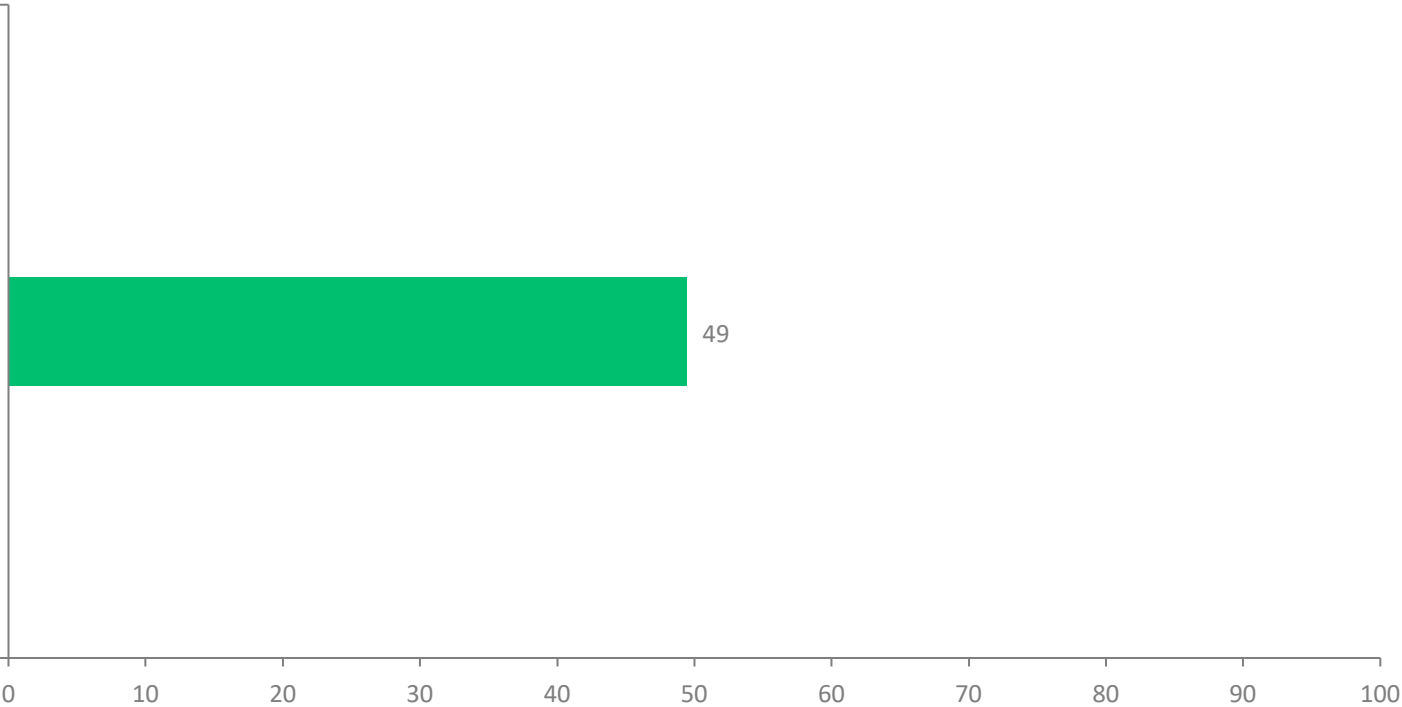
